

TOYO TIRES SPIN & WIN 2019 PROMOTION TERMS & CONDITIONS

IMPORTANT: PLEASE READ THROUGH THESE TERMS AND CONDITIONS (“TERMS & CONDITIONS”) BEFORE ENTERING THIS PROMOTION AND YOU CONFIRM THAT YOU HAVE DONE SO BY ENTERING THE PROMOTION. THIS IS A LEGALLY BINDING AGREEMENT BETWEEN YOU AND TOYO TYRE SALES AND MARKETING MALAYSIA SDN BHD (“TOYO MALAYSIA”) ESTABLISHING, UNDERSTOOD, AND AGREE TO ABIDE BY THE TERMS AND CONDITIONS UNDER WHICH YOU ARE ENTITLED TO PARTICIPATE IN THIS CONTEST.

1. Organiser and Promotion

- 1.1 This Promotion is organized by Toyo Tyre Sales And Marketing Malaysia Sdn Bhd (1128074-X) and/ or Silverstone Marketing Sdn Bhd (74191-D) (hereinafter referred to as “the Organiser”) and is open to all Malaysians and residents of Malaysia aged 18 years and above on or before the Promotion closing date.

2. Promotion Period

- 2.1 Promotion period (hereinafter referred to as the “Promotion Period”): 26 October– 30 November 2019.
- 2.2 Any redemption received after 12:00 midnight on 30 November 2019 will not be entertained or eligible for the Promotion.

3. General and Product Eligibility

- 3.1 This Promotion is limited to customers who purchase any two (2) pieces of Toyo Proxes TR1 tyre within the Promotion Period at Toyo Premium Auto Centre/Toyo Auto Centre and other participating outlets.
- 3.2 Only redemption with original receipts will be accepted.
- 3.3 Only individuals are eligible to participate in the Promotion. Groups, organisations and company entries are not allowed.
- 3.4 Employees of TOYO MALAYSIA and its related corporations, dealers, wholesalers and their immediate family members are not eligible to participate.

- Click “SUBMIT” to receive SMS verification code..

- Spin the wheel to receive e-voucher or football match tickets.
- Click “REDEEM” to direct to Toyo Tyre Malaysia Facebook page to click “LIKE & SHARE” to complete the process.
